The Town Board approved Mr. Arnold coming in as a part-time employee. An agreement between the Town and SEH is underway.

In speaking with Mr. Roukema, Mr. Garcia discovered the need for an updated building code. He planned to bring it to the Planning Commission for review, along with proposed public hearings, in October.
