ORDINANCE NO. 347

AN ORDINANCE OF THE TOWN OF IGNACIO, COLORADO, DEDICATING A PORTION OF PIONEER STREET PREVIOUSLY VACATED IN RECORDED PLAT NUMBERED 563932

WHEREAS, the Town of Ignacio (Town) previously vacated several street and alley right of ways reflected in a Vacation Plat (Plat) recorded on June 8, 1988 and assigned recording number 563932 by the La Plata County Clerk; and

WHEREAS, the Town subsequently dedicated by ordinance some of the vacated sections of right of way identified in the recoded Plat, but did not execute an ordinance for a portion of Pioneer Street; and

WHEREAS, the Town seeks to dedicate the vacated portion of Pioneer Street to adjoining property owners.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF IGNACIO, AS FOLLOWS:

- 1. Attached Exhibit A titled, Street & Alley Vacation Plat to the Town of Ignacio, Colorado, was approved in June of 1986 and recorded in June of 1988. This Plat, in part, identifies a section of Pioneer Street that is vacated from the west line of West Alley, to the east line of Hillside Drive, and along the southern lot lines of Lots 22-25, Block 14, and the northern lot lines of Lots 14-17, Block 15.
- 2. The vacated portion of Pioneer Street denoted above and in the subject Plat also reserves a 20-foot utility easement extending 10 feet on each side of the original centerline.
- 3. The portion of Pioneer Street denoted above hereby is vacated, with title vesting to the owners of land abutting the vacated portion of Pioneer Street in accordance with C.R.S. 43-2-302 et seq.
- 4. The Town hereby retains the easement over, under, and through the above described vacated portion of Pioneer Street for water, sewer, electric, gas and any and all other utilities for the purposes of maintaining, placing, altering, erecting or servicing in any way.
